- 1. Do not use the product if you:
 - (1) Have ever experienced allergic symptoms to this product or any ingredient of this product.
 - (2) Have ever suffered from asthma.
 - (3) Are pregnant or possibly pregnant.
 - (4) Children under 15 years old.
- 2. Do not use the product onto the following areas:
 - (1) Areas around the eyes and mucous membranes
 - (2) Sensitive areas of the skin (e.g., face, head, armpits)
 - (3) Eczema, rash, or wounded areas
 - (4) Athlete's foot/ringworm or purulent skin

[Dosage and Usage] Rub an appropriate amount onto the affected area three to four times a day. Do not cover the applied site with a plastic film or other non-breathing materials. Do not use other external drugs containing the same ingredient as in this product.

<Pre><Pre>cautions Related to Dosage and Usage>

- (1) Children under 15 years old should not use this product.
- (2) Strictly follow the dosage and usage.
- (3) Because it is for relieving symptoms such as pain or swelling, but not for treating the disease that causes pain or swelling, use only when you have symptoms.
- (4) Be careful not to apply to the eyes. If it touches the eyes, immediately rinse the eye with cold or lukewarm water. Visit an ophthalmologist if you experience severe symptoms.
- (5) This medicine is only for external use.
- (6) Do not use more than 50 g per week.
- (7) Do not apply other external drugs onto the same area as for this product.
- (8) Do not cover the applied site with a non-breathing materials (e.g., plastic wrap, corrective belt) making it occlusive.
- (9) Wash your hands after use.
